

## The country is happier

British business is booming and people are getting more happy with life than they were before the global financial crisis. All this contained in two studies published in November.

Businesses in the UK services sector have hired more staff last month and at the fastest pace for more than 15 years as a result of business growth which could well reach 1.3% by the end of the year.

That the recession is being tackled properly can be seen by private sector jobs growth now running at some 100,000 per quarter - higher than the average of 70,000 seen over the past year. Financial data provider Markit said "Business is picking up and firms are recruiting like we've never seen before."

To make the recovery it even better it is suggested that the Bank of England is likely to raise its growth forecasts.

Another survey by the Organisation for Economic Co-operation and Development has come up with the finding that British people are more satisfied with their lives than they were five years ago!

November's employment figures are the latest piece of encouraging news for the British economy. Employment has increased by 177,000 in the last quarter, there are now 1.1 million more people in work in the last three months. The number of young people in work increased by 50,000, while the number claiming Jobseeker's Allowance fell by 13,000 – the 17th consecutive monthly fall.

## Nelson Mandela

## George Osborne's Autumn statement

Chancellor George Osborne has delivered his Autumn Statement, describing it as a plan to deliver a "responsible recovery".

He outlined a brighter economic climate than a year ago, but said "difficult decisions" still needed to be made.

Yet, he took the opportunity to announce eye-catching plans about the state pension and taxes on small businesses.

A number of measures had already been announced, including some during the Budget in March and others at the party conferences.

So what does this latest statement mean for you?

Are people being made to work longer? Not everyone. People in their 20s, 30s and 40s might have to work for longer before they get their state pension, in line with improving life expectancy.

The state pension age is already rising to 66 by 2020 and 67 by 2028. It was then expected to go up to 68 between 2044 and 2046. Now that rise to 68 is going to come in earlier – in the mid-2030s.

There will be a rise of 2.7% in the state pension in April, or £2.95 a week.

Under the government's triple-lock system, the state pension increase is the highest of CPI inflation in September, average wage rises, or 2.5%. This year, CPI inflation was the highest of the trio.

### Welfare spend cap

The chancellor also announced a plan to cap welfare spending overall, excluding the state pension and jobseeker's allowance.

### For families

Mr Osborne confirmed plans for free school meals for infants.

He repeated the plan for a tax break for about four million married couples. Some £1,000 of personal allowance (the amount people earn before paying income tax) could be transferred from one spouse to another, assuming neither is a higher-rate taxpayer and one is earning less than the personal allowance.



He also confirmed that energy bills would not rise as much as expected with a change to green levies.

### For motorists

The chancellor had news for drivers. The next fuel duty rise was scheduled for September 2014, but this will be cancelled, saving drivers two pence a litre.

Tax disc to show motorists have paid vehicle excise duty is to be replaced with an electronic system.

From October next year, drivers will be able to pay by monthly direct debit rather than with a payment every year or six months.

### Small businesses

The chancellor said business rate rises would be limited to 2% in England and Wales next year instead of being linked to inflation. Business rate relief for small firms will be extended until April 2015.

There is also a two-year plan for a discount on business rates for some small traders on the High Street.

Employers will also get a break from National Insurance contributions when employing younger workers. At present it kicks in at the age of 16, but it will now be delayed to 21.

This will be one of the most expensive measures for the Treasury, costing £465m in 2015-16.

There is some movement calling for the Referendum on Europe to be held before the 2017 promise and many of our supporters agree. We are the only party that has promised a referendum with the power to see it through but we must have some promise of success before we fight in 2015. To have Europe accede to some of our wishes prior to the election will help us to win back those voters who have deserted us for just empty promise and more promise.

Conservatives have always valued a reputation for doing the right thing and we have to persuade our voters to trust us to deliver.

## David Cameron speaks out on protecting children

Back in July, I said I wanted to do more to protect our children online: a personal mission for me. In the summer, we took some important steps to help parents. Internet service providers agreed to introduce family friendly filters, which are installed automatically in the home unless a parent chooses otherwise, and stop children from looking at inappropriate material online.

But when it came to stopping people accessing child abuse images and videos through internet searches, the search engine companies said that nothing could be done.

I refused to accept that.

Over the past few months we've worked closely with Google and Microsoft – and we've made important progress.

Today they have set out a number of measures to block child abuse images and videos. No illegal child abuse material will be returned for 100,000 search terms.

This is encouraging - but if the internet companies don't continue to make progress I will not hesitate to take further action. We will do all that's necessary to protect our children..

£210 saved on council tax because we have given money to councils to freeze it, rather than letting council tax increase by 5 per cent each year – as it did under Labour (DCLG Press Release, 27 March 2013).

## Barrie Byford mourned

Barrie Byford who survived the IRA bombing of Brighton's Grand Hotel has died, aged 82. He was past chairman of one of Leicesters best known hosiery companies.



Well known as a Conservative member, he was involved in local and regional politics as chairman and treasurer, his last post being president of Loughborough Conservative Association. Barrie was well known to many party members in Nottinghamshire.

He and his wife, Hazel, Baroness Byford, now a Conservative peer in the House of Lords, were at the Grand Hotel in 1984 when an IRA bomb – planted to kill Margaret Thatcher and her government – exploded. They were uninjured.

He married Hazel in 1962 and they had two children, Elizabeth and Charles, and three grandchildren, Stephanie, Edward and Toby.

He qualified as a stockbroker and joined Hill Osborne as a consultant, where he spent 22 years.

His daughter Elizabeth Green said: "Always a quiet, understated man – he appreciated the lifestyle he was afforded and was always mindful of those less fortunate than himself."

"From the many letters received 'a true gentleman' is the phrase that best sums him up. He always had time for others".

"Father gave so much to so many. When asked to say Grace, he ended it with the words 'may we be ever mindful of the needs of others'. His sense of duty was immense".
